## 8-MW POWER SUPPLY CONTRACT WITH SAN MIGUEL POWER TO STABILIZE ENERGY DEMAND IN ZAMSURECO-1 COVERAGE





n the Energy Regulatory Commission (ERC) Evidentiary Hearing last October 24, 2017, ZAMSURECO-I General Manager & Chief Executive Officer Jose Raul Saniel reported before the Honorable Commission that the 8-MW power supply contract with San Miguel Consolidated Power Corporation (SMCPC) is viewed to stabilize ZAMSURECO-I's supply in the projected increase of energy requirements of Zamboanga Peninsula.

In his expository presentation, GM/CEO Saniel said that the economic activities of Mindanao are observed to be very dynamic. "Zamboanga Peninsula's contribution to the growth in Mindanao is around 4 to 5% which are driven by industrial and service developments. These energy-driven businesses require sufficient long-term power." GM Saniel said.

The power supply situation in Mindanao also urged the Management team and Board of Directors to enter into a power supply contract with SMCPC wherein NPC-PSALM, which supplies the bulk of electricity in Mindanao, has drastically reduced its energy allocation to electric cooperatives including ZAMSURECO-I. "One of the major reasons why we entered a power supply contract with SMCPC is to offset the capacity that has been reduced from PSALM's power plants." GM Saniel said.

GM Saniel said that SMCPC's 8-MW capacity is a necessity for long-term supply aimed to eliminate power supply deficiency. The recent power supply agreement with SMCPC augments the 8.19-MW deficiency of ZAMSURECO-I which will now add to 7.34-MW from NPC-PSALM, 15-MW from ThermaMarine and 12-MW from Therma South totaling into an aggregated supply of 42.34-MW supply of the Cooperative. *"We do not want to experience power curtailments again. We want to ensure because this is our mandate to provide reliable sufficient power supply to our member-consumers."* GM Saniel said.

#### **PROCUREMENT PROCESS**

On procurement process, GM Saniel presented during the hearing that ZAMSURECO-I complied with all government regulations issued by the Department of Energy (DOE) and Energy Regulatory Commission (ERC) on Competitive Selection Process (CSP).

The ZAMSURECO-I BAC conducted a CSP held last February 9, 2016 and published the notice of invitation to bid to prospective bidders twice to the national and local public. As a result, GM Saniel said that BAC declared failure of bidding as only one (1) gualified bidder, who is SMCPC, that submitted a proposal. On March 1, 2016, BAC issued Resolution No. 10 which resorts to direct negotiation with SMCPC for the procurement of the 8-MW electric energy. The technical working group on power supply invited SMCPC for a meeting and deliberation on the features of SMCPC's offer and made its endorsement to the Board of Directors. The Board of Directors then issued B.R. No. 26 authorizing its Board President to sign into the power supply contract. On March 14, 2016, ZAMSURECO-I and SMCPC executed the power supply contract subject to joint application. "Nag-umpisa tavo sa proseso." GM Saniel said.

The main consideration made was San Miguel Consolidated Power's capability to provide power immediately as their coal-fired power plant is currently operational in Malita, Davao. ZAMSURECO-I also put into consideration the SMCPC rate structure which entitles the Coop to a discount premium depending on its collection and payment performance.

#### FEATURES OF THE POWER SUPPLY CONTRACT

EDP/ISD Manager Azucena Lagura discussed the salient features of the contract that includes a term of 10 year-supply of an 8-MW contracted capacity from its commercial operation date. EDP/ISD Lagura said that in the duration of the contract, the SMCPC will be granting a prompt payment discount (PPD) and collection efficiency discount which differs from other power supply contracts.

"One of the important factors being considered is the rate to be charged to ZAMSURECO-I out of the capacity to be supplied. Its rate impact to member-consumers underwent careful simulation and review." said EDP/ISD Manager Azucena Lagura.

EDP/ISDM Lagura said that the rates to be charged to ZAMSURECO-I under the contracted capacity covers the generation costs only. Based on the contract,



ZAMSURECO-I shall pay the contract charges which consists 2 major components – capacity fee and energy fee. The capacity fee is composed of capital recovery fee of Php 1,386.8021 and fixed operation and maintenance fee of Php 383.8079 per kilowatt with a total of Php 1,770.61 per kilowatt. The energy fee consists of 2 sub-components which are the variable operations and maintenance of 0.2831 centavos per kilowatt hour and fuel fee of 1.6566 per kilowatt hour a total of 1.9397 per kilowatt hour.

On the basis of actual energy delivered, the monthly payment computed based on the formula: The monthly contract charges equals the capacity charges for the month and energy charges of the month.

EDP/ISDM Lagura presented the conditions of the contract wherein ZAMSURECO-I may avail of the promptpayment discount equivalent to 1% of the total of capacity and energy charges and other components of the current power bill except WESM charges and replacement power costs if any, provided that the Cooperative has no arrears from its previous power billings. ZAMSURECO-I must also meet the criteria of submitting all BIR tax certificates, full payment of power bill on time and compliance of other policies and procedures as may be required by SMCPC subject to prior notification.

Considering that ZAMSURECO-I sustained its 100% collection efficiency for the past eleven (11) years, EDP/ISD Manager Lagura said that the ZAMSURECO-I will be expecting to have a 20 centavos per kilowatt hour discount provided that ZAMSURECO-I has met the conditions: has no outstanding obligations from previous power bills , has submitted a copy of its monthly financial statistical report, collection efficiency report, audited financial statements and duly accomplished collection efficiency discount form.

#### MINIMAL RATE IMPACT ON GENERATION COST

On the rate impact, EDP/ISDM Lagura discussed the analysis and simulations made based on projected energy purchases for 2016. "As what GM Saniel said, ZAMSURECO-I signed the contract sometime March 2016 so we based also the computation for the rate impact in 2016 using its DDP projections." EDP/ISDM Lagura said. To create a rate impact analysis, EDPM/ISDM Lagura presented 3 scenarios using its existing power suppliers' ERC approved rates in 2016 based on the following data: PSALM's generation charge for the month of February 2016, ERC-approved rate of Mapalad Power Corporation (MPC), TSI and TMI's approved rate for the year.

Scenario 1 on actual billing from its power supplies revealed a blended generation rate of Php 4.1897 per kWh for February 2016. Scenario 2 assumes SMCPC is not supplying capacity to ZAMSURECO-I wherein the simulation utilized the forecasted average monthly energy purchased in 2016. The calculation resulted in a proposed generation mixed rate of Php 5.0485 per kilowatt hour. Scenario 3 assumes SMCPC supplying 8-MW to ZAMSURECO-I that showed a proposed mix generation result of Php 5.1284 centavos per kWh.

Presenting the analysis and simulation, an expected rate increase of PhP 0.0799 centavos per kWh is said to impact the consumers' billing statement from the power supply contract with SMCPC.

To analyze its impact to its end-consumers, EDP/ ISDM Lagura presented a sample billing computation for a residential customer consuming a monthly consumption of 100-kilowatt hours. Utilizing first the existing blended rate of PhP 4.1897 would result in Php 418.97 per month whereas applying the proposed generation mixed rate without SMCP's supply of Php 5.0485 per kWh would give Php 504.85 per month. The existing blended rate versus the rate without SMCPC's supply will generate into an increase of Php 85.88 per month.

Another sample billing computation on residential customers consuming 100-kWh was made to gather the rate impact of the said power supply contract. The said existing blended rate of PhP 4.1897 per kwh in comparison with the proposed generation mixed rate, now with SMCPC's supply to ZAMSURECO-I of PhP 5.1284 per kwh, will generate into an increase in the residential customer's monthly bill of PhP 93.87 per month on the generation charge in particular.

Applying both, a residential customer with 100kWh consumption is expected to have an increase of only (Php 512.84 per month less Php 504.85 per month) PhP 7.99 only per month on his/her generation charges. The increase of Php 7.99 inversely results in a decrease of power shortage which is viewed to stabilize power supply, to lessen brownouts and reduce customer complaints.

The ERC Hearing was held at ZAMSURECO-I Central Office and was presided by Atty. Imelda Myra Hagad, ERC's Hearing Officer with ERC Clerk of Commission Atty. Maria Adela Ching. ZAMSURECO-I Board of Directors, Management Team, employees, MSEAC, media partners and other stakeholders also attended the hearing.

# **LUMAYAS, RABON & GARBAN, JR.** RE-ELECTED AS Z-1 BOARD OF DIRECTORS

series of district elections transpired last November 2017 resulting in the re-election of the incumbent Directors Danilo Lumayas, Jeffrey Rabon and Maurecio Garban, Jr. of District VI, VII & VIII, respectively.

Directors-elect Lumayas, Rabon and Garban ran unopposed which opened to a ceremonial voting in their respective districts. The election turnout enabled Lumayas to garner 111 votes last November 11 in San Pablo Gymnasium while Rabon harboured 106 votes in District VII on November 18 followed by Garban, Jr. of District VIII who harvested 119 votes last November 25, 2017.

Held at San Pablo, Vincenzo Sagun and Pitogo Gymnasiums, the directors-elect were immediately proclaimed as winners by District Election Committee (DECOM). The three directors are set to serve their second terms for office for another three (3) years.

The election, which was expected to take place in June 2017, was pursued in the last quarter of 2017 due to the declaration of Martial Law in Mindanao. Said declaration initiated National Electrification Administration (NEA) to announce the deferment of scheduled elections in the 2nd and 3rd quarter of 2017.





## ZAMSURECO-I ROLLS OUT MSEAC RE-ORIENTATION DRIVE 2017



o further boost the efficacy of its Multi-Sectoral Electrification Advisory Council (MSEAC), ZAMSURECO-I Management, with the active support of the Board of Directors, rolled off the first two waves of its MSEAC re-orientation drive on December 2017.

The first batch was composed of MSEAC from Districts IV, V, VI and XI last December 08, 2017 at Central Office, Pagadian City which was followed through on December 18, 2017 with District I, II and III MSEAC held at Bonifacio B. Lagura Multi-Purpose Hall, Area-I.

Recognizing the crucial role of MSEAC in strengthening member-consumer-owner involvement, ZAMSURECO-I Management team headed by its General Manager & Chief Executive Officer Jose Raul Saniel led the discussion on the governing duties and responsibilities of MSEAC in an electric cooperative.

GM Saniel started off that the rationale behind the reorientation drive is because of the EPIRA law which states that all end-users including member-consumers must be educated and protected. GM Saniel said that MSEAC, being partners of the Cooperative, plays a critical role because of its responsibility in achieving the said mandate to its member-consumers owners.

He said that the design of the electric cooperatives as public utilities is unique because it is democratic and participatory by nature wherein there must be representatives from the people who will act as link between the member-consumers and the electric cooperative. "In the decision-making process, members could participate in the affairs of the organization." GM Saniel said.

GM Saniel challenged its MSEAC to come up with vital inputs for Board of Directors to establish sound policies and effective programs by means of connecting each sector – agro-fishery, business, civic, education, media, local government, batangas council women and youth sector to the Coop's activities and programs. *"We* 



are a public utility. We are endowed with essential public service functions because people requires our services." GM Saniel said.

ISD/EDP Manager Azucena A. Lagura discussed the MSEAC member qualifications, mechanics of the organization, its main functions together with the new and enhanced roles which requires active MSEAC participation.

Ending the orientation, GM Saniel encourages the MSEAC to take an active involvement in order for the cooperative to have a strong base of member-consumerowners.

The refresher course is part of the Coop's capacity-building program for MSEAC as catalysts for welfare development of member-consumers. The event was made possible through the efforts and initiatives of the Management team which was duly participated in by the Board of Directors.

The third wave of the re-orientation drive is expected to pursue in the year 2018.

## **GM SANIEL TALKS ON CLIMATE CHANGE DURING A DISASTER-RISK REDUCTION & PREPAREDNESS SEMINAR**

esponding to the seminar invitation from the Iglesia ni Cristo Molave, GM/CEO Jose Raul Saniel talked as the resource speaker on Climate Change during the Disaster-Risk Reduction and Preparedness Seminar-Workshop last December 02. 2017.

In his presentation entitled "Climate Change: What can we do to save Mother Earth?" GM Saniel presented the factors affecting the changes in the climate wherein humans and activities are the main contributors of the pressing issue.

Based on his research, human activity such as burning of fossil fuels for industry consumption emits the largest source of carbon dioxide. The carbon dioxide released alters the greenhouse gas content of the Earth's atmosphere which results in global warming.

GM Saniel said that in the pursuit of economic development and industrialization, countries worldwide have extracted and cultivated the environmental resources in excessive ways resulting in its gradual destruction. The destruction is manifested in disastrous events like Super Typhoon Yolanda which devastated thousands of lives and property among others.

"Since climate change affects everyone, therefore, it is everyone's problem." GM Saniel said. He shared that the alarming situation of the Earth can still be remedied by producing individuals with qualities of the 4A's namely Awareness, Appreciation, Advocacy, and Activism. "Producing these individuals are salient in advancing the cause of saving our environment." GM Saniel said.

Being the General Manager & CEO of an electric cooperative, GM Saniel encouraged the participants to conserve the use of electricity and other electricity-related activities in order to lessen the emission of harmful gases.

His passion on the issue caused him to inform the participants that ZAMSURECO-I is also conducting its own contribution for Mother Earth. He said that the Cooperative is gradually adapting to the use of renewable energy solar, biomass, hydropower, as source of electricity.

GM Saniel ended his talk by saying, "There is no place like home (Earth) and there will never be one again." He then encouraged everyone to do their part to help heal Mother Earth.

The seminar-workshop was facilitated by the Iglesia ni Cristo in coordination with the Municipal Disaster-Risk Reduction and Management Council (MDRRMC) of Molave and ZAMSURECO-I held at the Z-1 Bonifacio B. Lagura Multi-Purpose Hall, Switch, Ramon Magsaysay.

Mr. Danilo Caballero, Chapter Service Representative for Safety Services and Disaster Management Services with Hamla Laguiab and Renier Bangona, Safety Service Instructors led the seminar workshop at ZAMSURECO-I Bonifacio B. Lagura Hall, Area I Office, Ramon Magsaysay.

The lecture translated into live demonstration, engaged the trainees and employees to a hands-on exercises. The seminarworkshop also enabled participants to demonstrate the different methods of transfer for a safe transport of the victim during emergencies. Employees also were exposed to basic cardiac arrest and cardiopulmonary resuscitation (CPR) measures which composes the combination of two (2) procedures: lung ventilation and chest compression.

## HANDS-ON TRAINING ON CT/PT EQUIPMENT TO STRENGTHEN COOP'S TESTING PROCEDURE



s part of its strategy to enhance capacity of its employees and strengthen equipment standard testing procedures, 4 rewinding and 2 metering employees with the Coop's audit team attended the end-users' training on its acquired CT/PT testing equipment held at ZAMSURECO-I, Tiguma Office. The Coop's electrical engineers led the lecture and demonstration training on the basic features of the equipment.

The training is pushed to educate selected technical employees on the proper usage and beneficial impacts of the said equipment. Employees were then exposed to a handson demonstration to familiarize the features of the tester. The CT/PT testing equipment, which is used for measure the efficiency of its current and potential transformers, is procured by the Cooperative as one of its strategies to reduce system loss.

The CT/PT equipment is said to be used as its main testing tool in the operations of ZAMSURECO-I. At present, the Coop's testing procedures were enhanced as the rewinding and metering employees no longer need to secure the services of external parties for testing which opened the Coop's in-house testing parameters.

## ONE-DAY COMMUNICATION WORKSHOP TO BOOST EMPLOYEES' BASIC COMMUNICATION KNOW-HOW

elected ZAMSURECO-I employees and other ZAMPEN electric cooperatives broadened their basic communication skills as they attended a one-day communication workshop conducted by Aboitiz Power Corporation held at ZAMSURECO-I Heroes' Hall.

The workshop tackled press release writing and print communication, which enabled employees to make writeups that capture the reader's interest and attention. A short activity on message relay also taught participants to keep news information clear and concise in order to maintain the relevance of the story to its target audience. ### **DOE Pursues Energy Resiliency Policy** 07 December 2017





HILRECA Executive Director/ General Manager Wendell V. Ballesteros together with Deputy Executive Director Atty. Paul Heherson M. Balite participated in the Energy Resiliency Public Consultation held in Pontefino Hotel, Batangas City last 10 October 2017.

Acknowledging that disasters adversely affect the economy, environment and the people, the Department of Energy (DOE) vows to pursue a policy towards a resilient energy sector.

"Being one of the most vulnerable countries to disasters, the Philippines needs to ensure that our energy systems are disaster-resilient and that resiliency is an integral component of our policies and programs," says Energy Secretary Alfonso Cusi.

"The policy is a priority of DOE, following President Rodrigo Duterte's pronouncements to improve the disaster preparedness and resiliency of the country," he explains.

"The policy requires all the energy players to put upfront the mainstreaming of disaster risk reduction programs into planning and investment, to ensure the continuous delivery and strengthening of the existing energy infrastructure," he adds. In June, President Duterte signed Executive Order No. 29 which renames the National Disaster Consciousness Month to National Disaster Resiliency Month, to emphasize the shift of focus from disaster awareness building to disaster resilience.

The "Adoption of Resiliency Planning and Program in the Energy Industry to Mitigate Adverse Effects Brought About by Disasters" policy has four guiding principles:

- 1. Acknowledge the need to strengthen the existing energy infrastructure, facilities and systems to prepare and mitigate the impacts of disasters;
- Implement the build back better principle in terms of reconstruction and rehabilitations of damaged infrastructure;
- Improve existing operational, maintenance and procedures to ensure continuous operations and energy supply; and
- Develop resiliency practices, systems and standards that will be used as basis in future construction of energy facilities.

In line with this thrust, DOE started to conduct a series of public consultations on energy resiliency policy on 10 October in Batangas. This was followed by two other meetings in Leyte and Cagayan de Oro on 13 - 14 October respectively.

PHILRECA actively participated in the Energy Resiliency Public Consultation held in Pontefino Hotel, Batangas City and is closely monitoring further activities consistent with the same goals.

DOE Director Patrick Aquino lauds PHILRECA and its member-ECs for their 'Task Force Kapatid' which is a bayanihan quick response of Electric Cooperatives to come to the assistance and aid of ECs affected by a natural calamity.



# Marawi Power Restoration Rapid Deployment task force launch

he National Electrification Administration (NEA) has joined hands with various electric cooperatives and allied organizations in providing all the necessary assistance to ensure the speedy rehabilitation of the damaged distribution lines and power restoration in areas affected by the five month-long battle between the government troops and the ISIS-linked Maute terrorist group in Marawi City.

Administrator Edgardo Masongsong on Monday (November 13) led the launching ceremony of the Marawi Power Restoration Rapid Deployment (PRRD) Task Force at the Lower Capitol Complex, with Housing Assistant Secretary Felix Castro Jr., field manager of Task Force Bangon Marawi.

The Marawi PRRD Task Force is composed of the Association of Mindanao Rural Electric Cooperatives, Inc. (Amreco), the Philippine Rural Electric Cooperatives Association, Inc. (Philreca), the National Association of General Managers of Electric Cooperatives, Inc. (Nagmec), the National Center of Electric Cooperative Consumers, Inc. (NCECCO) and other allied organizations.

In his speech, Masongsong thanked the different electric cooperatives for responding to the call to help the Lanao del Sur Electric Cooperative, Inc. (Lasureco), currently under the management of Task Force Duterte Lanao Sur Power. With the technical assistance, the NEA chief set a target of completing the power restoration and rehabilitation works in 15 to 30 days.

"There are 34 electric cooperatives all over Mindanao that we are mobilizing to help Lasureco, to help Marawi, to help the Task Force Duterte Lanao Sur Power. We believe that our united effort to help our brethren living in this part of Mindanao - Marawi City and the whole of Lanao del Sur - will bring the development that we wanted," he said.

Also, Masongsong announced that the agency is initially extending a loan amounting to P150 million to Lasureco that will be used for the procurement of the construction materials needed for the restoration of distribution lines. The said amount, the NEA chief explained, will be converted into subsidy chargeable to the funds for the reconstruction of Marawi.

He said he already instructed Deputy Administrator for EC Management Services Atty. Goldelio Rivera and Deputy Administrator for Technical Services Engr. Artis Nikki Tortola to process the loan.

"We are extending loan to the tune of P150 million so that Lasureco, the Task Force Duterte Lanao Sur Power will be able to procure [the necessary construction materials]," Masongsong said.

Meanwhile, Amreco and Nagmec have initially committed to deploy crew and equipment.

Amreco president Felix Vergara, Jr. said ECs in Visayas and Luzon which would also want help in the power restoration efforts could do so in the form of financial assistance.

"Ang advice namin sa ibang gustong tumulong na nasa Visayas at saka sa Luzon, kasi mahirapan na tayong magpadala ng crew at hindi na siya practical, they can convert their contribution into cash," Vergara said.

Also present at the launching ceremony of Marawi PRRD Task Force were Lasureco Acting General Manager Nordjiana Ducol, Nagmec president Sergio Dagooc, NCECCO national chairman Akmad Mamalinta, and general managers and Board presidents of different ECs in Mindanao.

# Agus-Pulangi rehab, Minpocor creation get backing from NEA chief

ational Electrification Administration (NEA) chief Edgardo Masongsong expressed optimism that the rehabilitation of the Agus-Pulangi Hydroelectric Power Plant (HEPP) as embodied in the proposed measure creating the Mindanao Power Corporation (Minpocor) will gain traction in the 17th Congress.

Speaking to reporters in Misamis Oriental recently, Masongsong said electric cooperatives in Mindanao are actively pushing for both facilities to remain under state control through a new corporate entity instead of giving them up for privatization. The NEA administrator is aware that the Electric Power Industry Reform Act (EPIRA) mandates the government to sell its capital-intensive power generation assets, but he believes it should make an exception for the Agus-Pulangi HEPP in the interest of Mindanao stakeholders.

*"Sana ang Agus at Pulangi maging governmentowned and -controlled corporation pero nasa pangangalaga ng Minpocor,"* Masongsong said at the sidelines of the 38th Annual General Membership Assembly of the Misamis Oriental II Electric Cooperative, Inc. last week.



Masongsong pushed for the creation of Minpocor during his stint as representative of the 1st Consumer Alliance for Rural Energy (1-CARE) partylist in the 16th Congress together with his fellow Mindanao lawmakers. While their consolidated legislations passed muster in the

Lower House, it failed to get support from their counterparts in the Senate, prompting Zamboanga City Rep. Celso Lobregat to refile the same under House Bill No. 122 last year.

Masongsong is hopeful the refiling of their proposed measure will generate enough votes for its enactment to finally maximize the potential of the Agus-Pulangi hydropower complexes, which are pivotal in keeping electricity rates affordable in Mindanao. "Ang potential niya 982 megawatts (MW) pero ngayon siguro nakaka-generate lang siya between 300 to 400 MW so nawawala 'yung more or less 500 to 600 MW. So sana pondohan na lang siya ng gobyerno sa pamamagitan ng Minpocor para mga taga-Mindanao ang mag-operate, mag-manage, mag-rehabilitate sa Agus at Pulangi," he said.

At this point, the fate of the Agus-Pulangi rests with the Power Sector Assets and Liabilities Management (PSALM), which has been tasked by the Joint Congressional Power Commission to determine the best available option for its impending privatization.

# NEA: Rural electrification must continue to spur growth

(NEA) will continue to push for the sustainable development of the nation's rural communities by providing electricity services to every Filipino household.

NEA Administrator Edgardo Masongsong issued this statement during the 36th Annual General Membership Assembly (AGMA) of the South Cotabato II Electric Cooperative, Inc. (Socoteco II) at the City Gymnasium, Lagao, General Santos City, on Saturday (October 14).

With the theme "Strengthening Our Pillars of Commitment Towards Service, Members' Welfare and Empowerment," the AGMA drew nearly 15,000 attendees. Part of the program was the ceremonial switch-on of the Sitio Electrification and Barangay Line Enhancement Projects (SEP/BLEP) within the area coverage of Socoteco II.

In his message before the member-consumerowners (MCOs) present, Masongsong highlighted the importance of rural electrification to spur development and reduce poverty as envisioned in the "Ambisyon Natin 2040." Electrification is aimed at improving the living conditions of the Filipinos, particularly those in rural and remote areas, he said.

"Hindi pa kumpleto ang rural electrification program hangga't marami pa ang mga mahihirap. Mangyayari lamang ito kung ang lahat ay umangat na ang antas ng pamumuhay at maaari natin itong marating kung patuloy nating susuportahan ang ating mge electric cooperatives," the NEA chief said.

Masongsong, at the same time, reiterated his appeal to all MCOs to support the National Center of Electric Cooperative Consumers, Inc. (NCECCO) movement, as well as the proposal to establish an Electric Cooperative

Consumer-Owned (ECCO) Bank that will cater to the financial interests of the electricity consumers.

As part of the program, the NEA chief sworn in the newly elected members of the Socoteco II Board of Directors (BOD). He likewise led the symbolic mass oathtaking of the coop's member-consumers as members of NCECCO movement that seeks to unite and empower all the MCOs nationwide.

Socoteco II is a triple-A rated electric cooperative and recipient of various awards, such as the Single Digit System Loss, EC Best Practice on Corporate Social Responsibility, and Fully Compliant EC on Reportorial Requirements, at the recent NEA Lumens Awards. Its franchise area include General Santos City, Sarangani Province, and Tupi and Polomolok of South Cotabato.

It also remains committed to its mandate on missionary electrification. To date, the coop achieved the 100 percent energization of the 205 barangays and is continuing to expand its distribution system to unelectrified sitios and puroks. For 2016, Socoteco II completed 141 electrification projects, 109 of which were funded by the coop's Reinvestment Fund and 32 were from the SEP and BLEP.

To improve power reliability and quality, Socoteco II also plans to implement major technical projects, such as construction of 35 MVA Substation for Tambler, General Santos City; construction of 10 MVA Substation for Malandag, Malungon, Sarangani Province; increasing of capacity from 5 MVA to 10 MVA for Tupi, South Cotabato; and uprating of capacity from 10 MVA to 20 MVA for Alabel, Sarangani.
